PAYMENT AGREEMENT: This Payment Agreement is a monthly Electronic Funds Transfer (EFT) agreement between the Brandon Wheat Kings, (BWK) and the Member for renewing a Season Ticket valid at all BWK Home Games played during a standard Western Hockey League regular season as listed in the Payment Account throughout the term of the Payment.

AUTOMATIC RENEWAL: This Payment Agreement is automatically renewed each year on April 1st, for a new twelve-month period.

PAYMENT ACCOUNT: Member agrees to purchase a renewing season ticket for the seating locations indicated on the reverse.

MONTHLY AGREEMENT EFT: Member agrees to allow BWK to debit the below listed credit card an amount equal Monthly Agreement EFT as listed in the Agreement on the 1st day of each month in addition a \$5.00 monthly processing fee. Should the Monthly Payment EFT date fall on a Saturday, Sunday or Holiday, the Monthly Payment EFT may be completed on the next business day. Monthly Payment EFT may take up to three days to complete.

CREDITS AND ANNUAL COST ADJUSTMENTS: BWK reserves the right to make reasonable ticket price adjustments once per year at the end of each season. BWK will notify the Member of the new adjusted Payment Account value and adjusted monthly EFT amount no less than 20 days prior to the first adjusted monthly EFT.

AVAILABILITY OF FUNDS: It is the sole responsibility of the Member to ensure that sufficient funds are available on/in the above listed credit card account to cover the Monthly Payment EFT during the payment window. Any third-party penalties, fees, or other adverse actions incurred by the Member, caused by the failure of the Member to make the agreed upon funds available are the sole responsibility of the Member and cannot and will not be assumed by the BWK.

FAILURE TO PAY: Should the above agreed upon funds not be available at the time BWK attempts to charge the above listed credit card account within the corresponding payment window, BWK reserves the right to charge the Member a \$25.00 late fee per each occurrence. Repeated occurrences may result in the discontinuation of Payment and refusal of entry to any and all BWK events. However, BWK will make at least one (1) attempt to contact the Member and secure payment prior to cancellation or refusal of entry.

RIGHTS AND RESPONSIBILITIES: Member is responsible to notify the Brandon Wheat Kings ticket office of all changes to Member information including mailing address, phone number, email address and payment information. Member is entitled to all the rights and responsibilities as outlined by BWK with the purchase of Brandon Wheat Kings Hockey Club season tickets. BWK reserves the right to revoke any and all of these rights at any time due to non-payment or inappropriate conduct at BWK events.

END OF PAYMENT RIGHTS: Member shall complete and sign a Payment Agreement Cancellation form (available at the BWK main office) and deliver to BWK via mail (#2 – 1175 18th Street, Brandon, MB. R7A 7C5) or email (office@wheatkings.com) no later than 30 days prior to automatic renewal on the Member Anniversary Date. Payments cancelled after automatic renewal on the Payment Anniversary date shall be charged an early termination fee equal to the Monthly Payment EFT plus the value of any and all games played during the final season of Payment.
